Keynote V

Presentation topic: Prevention Strategies based on Exposure-response Analysis of Silica Dust Exposure and Related Adverse Health Effects

Prof. Chen is Professor and Head of the Department of Occupational Health and Environmental Health in the School of Public Health of Tongji Medical College at the University of Science & Technology. She is also an Adjunct Professor in the Chinese University of Hong Kong. She obtained her bachelor and master degree in Tongji Medical University and a Doctoral Degree in Essen University of Germany in 2001.

Her major research interests include:

- (1) Epidemiology study on adverse health effects and preventive strategy of industrial dusts.
- (2) The pathogenic mechanism of ambient particle matters to cause cardiopulmonary diseases.
- (3) Evaluation on protective effects of personal respiratory protection equipment.

Prof. Chen is a member of the Chinese National Occupational Standards Committee and fellow of many national and international professional colleges and institutions in occupational health medicine and public health. She obtained the Alice Hamilton Award of US NIOSH in 2006, one first class prize of Hubei Scientific and Technology Progress Award in 2007 and one second class prize of Chinese State Scientific and Technological Progress Award in 2014. There are more than 150 papers being published by Prof. Chen and her group.

Presentation topic: The Overview of Rehabilitation Development in China, as in Comparing with Oversea Countries

Prof. Li is the president of the School of Rehabilitation Medicine in Nanjing Medical University. He is also the president of Zhongshan Rehabilitation Branch and the head of the rehabilitation medicine center in Jiangsu Provincial Hospital.


Prof. Li is the chairman of the International Society of Physical and Rehabilitation Medicine (ISPRM), chairman of the Chinese Association of Rehabilitation Medicine, and the deputy director of the Chinese Association of Physical Medicine and Rehabilitation. He is also the president of the Rehabilitation Physician Branch of the Chinese Medical Association, the vice-chairman of the Chinese Disabled Rehabilitation Association, and the chief science communication expert of Rehabilitation Medicine of the Chinese Science Association.

Prof. Li is the vice-editor of the Journal of Rehabilitation Medicine and the Journal of Chinese Rehabilitation Medicine, and the editor of the Journal of Spinal Cord Medicine. Prof. Li was elected as a foreign academician by the institute of Medicine of the National Academies.

Keynote II

Presentation topic: Early Care of Occupational Spine Pain - Collaboration between Workplace and Caregivers



Prof. Nordin (Dr. Med. Sci., PT) is Professor (Research), Departments of Orthopaedics and Environmental Medicine, School of Medicine, New York University (NYU), New York, NY, USA, Vice President of the World Spine Care and Chair of the Task Force on Research EuroSpine.

She is the founder and past Director of the Occupational and Industrial Orthopaedic Center (OIOC), NYU Langone Medical Center and the Past Program Director of the Program of Ergonomics and Biomechanics, Graduate School of Arts and Science, NYU. She has been a panel member of 5 larger taskforces: AHCPR Clinical Practice Guidelines for Acute Low Back Problems in Adults, the Quebec Task Force on Whiplash Associated Disorders, the Paris Task Force on Exercises, Low Back Pain and the Bone and Joint Decade 2000-2010 Task Force on Neck pain and its Associated Disorders, and Development of Minor Injury Treatment Protocol Project, Ontario Government.

Prof. Nordin's primary interest is to prevent disability for musculoskeletal disorders with a focus on spine. She is currently working with several projects focusing on evidence based medicine for spine pain, transfer of knowledge to different cultures and adaptation, and how to develop guidelines into health promoting policies.



Prof. Michael Sullivan

Keynote III

Presentation topic: Psychosocial Risk Factors for Problematic Recovery: Assessment and Intervention

Prof. Sullivan is currently Professor of Psychology, Medicine and Neurology at McGill University. He also holds cross-appointment with the School of Physical and Occupational Therapy and is Scientific Director of the University Centre for Research on Pain and Disability. He has lectured nationally and internationally on the social and behavioral determinants of pain-related disability. He is known primarily for his research on the relation between catastrophic thinking and pain experience, and for the development of community-based approaches to the management of pain-related disability. Prof. Sullivan also developed the Progressive Goal Attainment Program (PGAP); the first community-based intervention program designed specifically to target psychosocial risk factors for pain-related disability.

Prof. Sullivan has published over 160 scientific papers, 20 chapters, and 5 books. He currently holds a Canada Research Chair in Behavioral Health. In 2011, Prof. Sullivan received the Canadian Psychological Association Award for Distinguished Contributions to Psychology as a Profession.



Ms. Marcia Vernon

Keynote IV

Presentation topic: Transforming the Effectiveness of Recovery and Return To Work of People with a Work Injury in Australia

Ms. Vernon is Director, Health and Return to Work Services at ReturnToWorkSA in South Australia. She holds a Masters in Public Health (Workplace Health and Rehabilitation) and a Bachelor of Speech Pathology. She is a Certified Disability Management Practitioner and a Certified Personal Injury Professional through the Personal Injury Education Foundation in Australia.

Marcia has extensive experience as both a health practitioner, a practitioner of vocational rehabilitation, and as an injury management advisor to case managers in Australian Workers Compensation jurisdictions. She is currently responsible for regulating providers of health and vocational rehabilitation services to ensure people with a work injury receive the most effective and value for money services. She has been a strong contributor to the recent reforms in the South Australian Work Injury Scheme.

Marcia has a strong interest in facilitating early intervention, active and purposeful participation of all parties in the recovery and return to work process, and in supporting health professionals to better manage patients with a work injury.

Keynote VI

Presentation topic: Estimation of Health Benefits from Prevention: Savings of Loss-of-life Expectancy, Quality of Life, Functional Disability, and Healthcare Expenditures



Prof. Wang, M.D., Sc. D., is Chair Professor in Institute of Public Health of National Cheng Kung University College of Medicine. Dr. Wang mainly contributes on the following two fields:

1. Documentation of occupational and environmental diseases and help the government to establish the hazard communication system in Taiwan: After he obtained his Sc.D. from Harvard University and board certified in the American Board of Occupational Medicine, he came back to Taiwan in 1982 and has successfully documented about 20 different kinds of occupational and environmental diseases in Taiwan.
2. Development of a general equation to quantify health for comparative outcome/risk research and improvement of public health and efficiency of healthcare services: In collaboration with Dr. J.S. Hwang of Academia Sinica, they have successfully integrated the survival function with quality of life (QOL) function with the following equation in 1996: $\int E(Qol | x)S(t | x)dt$ to quantify health benefit for health condition xi under a common unit of quality-adjusted life year (QALY). Their studies of patients under prolonged mechanical ventilation facilitated the enactment of law for possible withdrawing ventilators under appropriate ethical constraints.

Presentation topic: The Overview of Korea Workers' Compensation System, Medical Management and RTW system for Injured Workers

Prof. Won is a physician and professor of The Institute for Occupational Health, Graduate School of Public Health, and Department of Preventive Medicine at Yonsei University College of Medicine in Seoul, South Korea. He is a chairman of Academic Committee in the Korean Society of Occupational and Environmental Medicine, and a director of General Affair in the Korea Academy of Independent Medical Examiners.

Prof. Won contributes to the Industrial Accident Compensation Insurance Re-examination Committee as a committee member. He serves in the Ministry of Employment and Labor as a member of Policy Making Expert committee on Industrial Accident Compensation Insurance and Evaluation Committee on Occupational Disease Investigation, He is also a member of Expert committee on Policy making for the Korean Workers' Compensation and Welfare Service.

Prof. Won strives for workers' health issues especially in the return to work for industrially injured workers and workers compensation system. He has also published a number of peer-reviewed papers, books, and articles. His current study focuses on workers' safety and health, worker's compensation, and prevention of industrial accident.




